## MAY 2025 BOARD MEETING

## UTILITIES MANAGER MIKE SUNDBY ALONG WITH CHARLES SLAGTER

- 1. I'D LIKE TO INTRODUCE YOUR NEW UTILITIES MANAGER CHARLES SLAGTER. I BELIEVE I'M A GOOD JUDGE OF CHARACTER AND I BELIEVE ADAM HAS HIRED THE RIGHT GUY FOR THE JOB.
- 2. WE CONTINUE TO HAVE MAJOR CONSTRUCTION ALONG HIGHWAY 89 WITH THE REPAVING, ELECTRICAL BOXES INSTALLED, AND THE CULVERT REPLACEMENT PROJECT ALL AT THE SAME TIME
- 3. WE WERE SCHEDULED FOR MAIN WATER LINE SHUTDOWN ON TUESDAY MAY 20<sup>TH</sup>. HOWEVER, THE CONTRACTOR PURCHASED THE WRONG SIZE PIPE AND FITTINGS.
- 4. WE RESCHEDULED FOR MAY 22<sup>nd</sup>. UNFORTUNATELY, WE WERE UNABLE TO ISOLATE JUST THAT AREA FROM HIDEWAY TO HUMPHREY CIRCLE AND WE HAD TO SHUTDOWN A PORTION OF GREENVILLE TO MAKE THE NECESSARY MAIN PIPELINE RELOCATION. AND ONCE AGAIN, A BOIL WATER NOTICE WAS REQUIRED AND GIVEN.
- 5. THE PIPELINE RELOCATION WAS REQUIRED BY CAL TRANS. APPARENTLY, OUR WATER MAIN CAME AFTER CAL TRANS CMP (CORRUGATED METAL PIPE). THE REPLACEMENT CMP WAS AT THE SAME ELEVATION THAT OUR 8" MAIN WAS AT AND REQUIRED RELOCATING.
- 6. PLUMAS COUNTY IS UNDER CONTRACT FOR THE MAINTENANCE OF GREENVILLE STREETSCAPE UNTIL SEPTEMBER 2025. PLUMAS COUNTY HAS COMPLETELY DROPPED THE BALL. NUMEROUS SHRUBS AND TREES HAVE DIED AND I BELIEVE WE SHOULD ASK FOR COMPENSATION TO REPLACE DEAD TREES AND SHRUBS. LAST WEEK, I REQUESTED THE KEYS FOR THE CONTROL BOX. WE ARE NOW TAKING OVER RESPONSIBILITY DUE TO PLUMAS COUNTY'S INABILITY TO ABIDE BY THE CONTRACT.
- 7. THE SOLAR POOL PROJECT IS COMPLETE ALONG WITH THE BEAUTIFICATION OF THE POOL AREA WITH NEW ROCK, BARK AND PLANTS. I CAN'T TEST THE SOLAR PANELS UNTIL THE POOL IS FILLED AND RUNNING.
- 8. THE PARKS BOARD IS ACTIVELY PURSUING THE POOL PLASTERING AND DECK REPLACEMENT PROJECT.
- 9. THE NEW PLAYGROUND EQUIPMENT IS BEING INSTALLED THIS WEEK AND LOOKS INCREDIBLE.
- 10. UNFORTUNATELY, GEORGE DECIDED TO QUIT RATHER THAN CHANGE JOB DESCRIPTIONS.
- 11. WE HIRED A YOUNG MAN FROM DIG IT. HIS NAME IS LUCAS MONTOYA. WE ARE VERY HAPPY TO HAVE HIM COME ON BOARD.

- 12. WE ARE PROMOTING SOMMER CUNNINGHAM TO THE POSITION OF FIELD SUPERVIOR. CONGRATULATIONS SOMMER.
- 13. AGAIN, GREENVILLE IS MY ADOPTED HOMETOWN. THANK YOU FOR ALLOWING ME TO TRY AND LEAVE IT IN A BETTER PLACE THAN BEFORE I CAME.
