## **Resolution # 10-25**

A Resolution of the City Council of the City of Isleton Memorializing Its Action of August 26, 2025, Approving Sewer Service Charge Adjustments Pursuant to Proposition 218

### **WHEREAS,**

Article XIII D of the California Constitution (Proposition 218) requires that property-related fees and charges be imposed only after notice to property owners, a public hearing, and the absence of a majority protest; and

### **WHEREAS,**

the City of Isleton caused to be mailed a notice of public hearing on proposed increases to sewer service charges to all record owners of property subject to the charges, at least 45 days in advance of the public hearing; and

### **WHEREAS,**

said notice described the amount of the proposed charges, the basis upon which the amount of the charges was calculated, the reason for the charge, and the date, time, and place of the public hearing; and

### **WHEREAS,**

on August 26, 2025, the City Council conducted the duly noticed public hearing, received written protests and oral testimony, and closed the public hearing; and

### **WHEREAS,**

at said hearing, the City reported receipt of nine (9) written protests, which did not constitute a majority protest under Article XIII D of the California Constitution; and

### **WHEREAS,**

following closure of the public hearing, the City Council approved sewer service charge adjustments pursuant to Proposition 218; and

**WHEREAS,**

the City Council now desires to memorialize its August 26, 2025 action by adopting this Resolution and establishing the new sewer service rates effective September 1, 2025.

**NOW, THEREFORE, BE IT RESOLVED,**

1. The action taken by the City Council on August 26, 2025 approving sewer service charge adjustments pursuant to Proposition 218 is hereby memorialized.
2. The sewer service charges are established as set forth in *Exhibit A*, attached hereto and incorporated herein.
3. Said charges shall become effective September 1, 2025, and shall be collected on a monthly basis through the City's utility billing system.
4. The City Manager, Finance Director, and City Clerk are authorized and directed to take such actions as are necessary to implement and administer said sewer service charges.
