**FIRST AMENDMENT TO  
LEGAL SERVICES AGREEMENT BETWEEN THE CITY OF ISLETON  
AND  
PRENTICE|LONG, PC**

THIS FIRST AMENDMENT for legal services is entered into by and between the **City of Isleton**, a general law city in the State of California (“City”), and **Prentice|Long, PC** (“Law Firm”), as of October \_\_\_, 2025 (the “Effective Date”).

WHEREAS, City and Law Firm have entered into a Legal Services Agreement (“Agreement”) dated January 7, 2025; and

WHEREAS, City and Law Firm desire to modify Section 1.3 (Assignment of Personnel) of the Agreement; and

WHEREAS, City and Law Firm further desire to modify Section 9.2 (Venue) of the Agreement.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 1.3 “Assignment of Personnel” is hereby amended to the Agreement to read as follows:

**1.3     Assignment of Personnel.** Law Firm shall assign only competent personnel to perform services pursuant to this Agreement. Sean Cameron will be assigned as City Attorney. Rebekah Mojica will be assigned as Assistant City Attorney. Gretchen Stuhr will be assigned as Assistant City Attorney for Human Resources. These positions may be amended with approval of the City Council.

2. Section 9.2 “Venue” is hereby amended to the Agreement to read as follows:

**9.2     Venue.** In the event that either party brings any action against the other under this Agreement, the parties agree that trial of such action shall be vested exclusively in the Superior Court for the County of Sacramento.

3. Except as herein amended, the Agreement dated January 7, 2025, shall remain in full force and effect.


