BACKGROUND:

During the 10/08/2025 Regular Meeting of the City Council, Councilmember Leah Turner announced her resignation from the City Council effective at the end of the day on 10/14/2025.

The City Council voted to fill the vacancy by appointment and directed staff to begin the application process.

EXECUTIVE SUMMARY:

Staff has received two (2) applicants by the deadline for the vacancy. The applications submitted are attached to this staff report.


Plumas County has confirmed that both applicants are within the City and are registered voters.
