RE: Appointment of Representative and Alternate to the Sacramento Transportation Authority Governing Board

BACKGROUND:

The Sacramento Transportation Authority (STA) is an independent local government agency responsible for administering the countywide transportation sales tax program (Measure A), which funds capital transportation projects and ongoing transportation programs and services throughout Sacramento County.

The City of Isleton receives a monthly formula allocation of Measure A revenues totaling approximately \$60,000-\$70,000 annually for eligible transportation needs. STA also assists local agencies in leveraging these local funds to obtain state and federal transportation grant funding.

STA is governed by a 16-member Board of Directors comprised of representatives from Sacramento County and its cities.

Under the established governance structure, the Cities of Galt and Isleton share one Board seat, with one councilmember serving as the representative and the other city providing the alternate. The appointment rotates every two years.

Per the adopted Galt-Isleton shared appointment resolution:

Isleton is the designated representative city for calendar years 2025-2026.

Galt serves as the designated alternate city during this period.

STA Resolution NO 11-24

The prior appointee, Councilmember David Kent, is no longer eligible to serve due to his vacancy from the City Council, creating the need for a new appointment.

STA has requested confirmation of Isleton's representative prior to its February 20 meeting.

DISCUSSION:

To ensure continued representation and participation in STA meetings and funding decisions, the City Council must appoint:

- One Councilmember as the STA Governing Board Representative
- One Councilmember as the STA Governing Board Alternate

The representative serves during their term of office and at the concurrent pleasure of the Cities of Galt and Isleton.

If the primary representative cannot attend a meeting, the alternate will attend and participate.

Timely appointment will ensure the City maintains its voice in regional transportation funding and policy decisions.

RECOMMENDATION:

Adopt a motion appointing one Councilmember as the City of Isleton representative and one Councilmember as the alternate to the Sacramento Transportation Authority (STA) Governing Board.

FISCAL IMPACT:

None.

Participation supports continued receipt and leveraging of Measure A transportation funding.

Good Morning Jon,

My understanding is that the City of Isleton's current appointment to the STA Governing Board (David Kent) may no longer be valid due to a change in residence, which could create a vacancy. STA's next meeting is **February 20**.

Could you please advise whether the City anticipates appointing a new representative prior to that meeting? If not, please confirm the City will notify the alternate for the February 20 meeting. For your use, I have provided background information below and attached the relevant documentation.

Background

The Sacramento Transportation Authority (STA) is an independent local government agency responsible for administering a countywide transportation sales tax program that funds capital projects and ongoing transportation programs/services. STA currently administers **Measure A**, a half-cent transportation sales tax measure in Sacramento County which is effective through 2039. The City of Isleton receives a monthly formula allocation of Measure A revenues, totaling approximately **\$60,000–\$70,000 annually**, for eligible transportation needs. STA also works with agencies to leverage these local funds with state and federal transportation grant programs.

STA is governed by a **16-member Board of Directors**, with membership established by resolutions adopted by Sacramento County and the cities. Under the applicable resolution language, **one councilmember serves as the Cities of Galt and Isleton representative**, appointed to serve during his/her term of office and at the concurrent pleasure of the City Councils of Galt and Isleton.

To maximize use of the shared seat, the Cities of Galt and Isleton have implemented a **rotational appointment system**, under which one city councilmember serves as the designated representative and the other serves as the designated alternate, consistent with the attached resolution. The rotation occurs every two years; **Isleton is the designated representative for calendar years 2025 and 2026**.

RESOLUTION NO. 11-24

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ISLETON,
CALIFORNIA, ESTABLISHING THE UTILIZATION OF A GALT-ISLETON SHARED
APPOINTEE TO THE SACRAMENTO TRANSPORTATION AUTHORITY BOARD
OF DIRECTORS**

WHEREAS, the Sacramento Transportation Authority (STA) is an independent local government agency primarily responsible for administering a countywide sales tax program to fund capital transportation projects and ongoing transportation programs/services; and

WHEREAS, the STA is governed by a 16-member Board of Directors; and

WHEREAS, STA resolution 2003-1182, which governs the composition of membership on the STA Board, states that the STA Board shall include: “One (1) Council person or other elected official of a local government entity who shall be appointed by and serve during his/her term of office at the concurrent pleasure of the City Councils of the Cities of Galt and Isleton”; and

WHEREAS, both the City of Galt and the City of Isleton seek to work together to maximize the utilization of the shared STA Board of Directors seat have agreed to utilize a rotational appointment system.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ISLETON,
CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

Section 1. The Cities shall share their seat on the STA Board of Directors as follows:

Calendar Years	Designated Representative City	Designated Alternate City
2023-2024	Galt	Isleton
2025-2026	Isleton	Galt
2027-2028	Galt	Isleton
2029-2030	Isleton	Galt
2031-2032	Galt	Isleton
2033-2034	Isleton	Galt
2035-2036	Galt	Isleton
2037-2038	Isleton	Galt
2039-2040	Galt	Isleton

Section 2. The Designated Representative City shall include the Designated Alternate City’s alternate appointee in any STA related briefings.

Section 3. The Designated Representative City’s appointee shall notify the Designated Alternate City’s alternate appointee if the regular appointee cannot attend a STA Governing Board meeting.

The City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.




