**RE:** Approval to Purchase Personal Protective Equipment- Structure Turnout Gear

---

**REQUESTED BOARD ACTION:**

Authorize Staff to purchase required replacement structure turnout gear.

---

**BACKGROUND:**

NFPA Standard 1851 states that structural turnout gear should be retired ten years from the date of manufacture. The structure gear owned by the Sierra Valley Fire District is outdated and needs to be replaced. The gear has been assigned to firefighters operating as the Sierra Valley Fire District, for many years and currently now with the Beckwourth Peak Fire District. It is important that the firefighters of the District have protective clothing which are compliant with NFPA and OSHA standards.

The proposal requests ten sets of structural turnout coats, pants, boots and helmets. Our vendor, Curtis Fire Equipment, has current purchasing contracts with large fire departments in California. We are able to purchase gear at the lowest rates, under the negotiated contracts to supply those departments with turnout gear and other fire equipment.

The total purchase request is \$42,475.72. Once ordered, the gear would be delivered by the end of March 2025. Curtis Fire Equipment has approved deferral of invoice payment until July 1, 2025, without interest, to give us an opportunity to receive our OES reimbursements and property tax funds, during the Spring.

**REASON FOR RECOMMENDED BOARD ACTION:**

The Board will consider and decide if this purchase is appropriate and necessary. Staff does not have the authority to make this large (monetarily) of a purchase.

## **FISCAL IMPACT:**

This is a large, unbudgeted purchase which has a potential negative impact on the current budget. The need to replace outdated turnouts is urgent, which became known and understood after auditing turnout gear over the last two months. We acquired extra compliant turnout gear from the merger with the Eastern Plumas Rural FD and distributed those, but we came up short with the majority of staff in Sierra Valley. We also have additional firefighter candidates starting the onboarding process.

Typically a fire agency will allocate annual budget funds towards the replacement of damaged and retired turnout gear. Much of the time gear can be recycled to other personnel when members leave. In the preparation of the next budget, we should factor in funds for regular replacement of turnout, in addition to outfitting new firefighters coming on board.

Considering this is not a budgeted purchase, the Curtis Fire Equipment Company will extend payment of the invoice until July 1, 2025, to give opportunity for the District to collect anticipated funds. This will allow outstanding OES invoices to be paid and tax allocation to be received in the Spring. This will reduce the impact to the current budget.

## **IMPACTS TO THE CUSTOMER:**

Positive impacts to the customer through providing firefighters with safe, compliant gear for interior firefighting and deferring payment to July 2025 reduces current budget negative impact.

## **RECOMMENDATION:**

Authorize purchase of the turnout gear as proposed. Attached is the detailed quote for the purchase, equipment description, unit price, total price and tax.
